| 1.1 | Initial introductions were undertaken. JB confirmed that James Thornton was acting as the Sustainability Lead for the team | NOTE |

| 2.1 | The 6 th edition of Newsletter has been distributed. (Note this is a monthly requirement). PMN – The 7 th edition has been drafted and is ready for distribution - by StreetPR an external distribution company engaged by TSL | JB |
| 2.2 | JT confirmed that the Sustainability Plan was being developed by James and his team on site. | JT |
| 2.3 | JT also confirmed that the on-site batching plant has significantly reduced CO2 and generally reduced emissions associated. He also confirmed that c6500 concrete wagon deliveries into site had been avoided | JT |
| 2.4 | JT confirmed that TSL were endeavouring to secure local labour and materials where possible. MA requested actual numbers engaged on site to be confirmed | JT |
| 2.5 | JT also confirmed that TSL were committed to sourcing locally based managers to support our growth in the region PMN: TSL have recently appointed an Assistant Design Manager, Temporary Works Manager and two Quantity Surveyors that live locally | NOTE |
| 2.6 | JT confirmed that TSL were planning to brief the full Supply Chain engaged on the project on TSL's Supplier Code of Conduct | JT |
| 2.7 | JT stated that TSL are keen to engage with Local Charities and develop relationships with during our build phase. Initial discussions have been held with the Charities previously suggested and TSL/AMZ were looking to offer support to those most in need of assistance It was confirmed that Ron Deering School had been contacted by TSL also, but no response received to date | NOTE |

MA raised concern re Noise emanating from site on the Eastern Boundary. JB confirmed that no noise exceedances had been logged in 2.10 the period on the Data Loggers held on site. JB also advised that TSL NOTE had been pushing to complete works on the eastern boundary to allow the external concrete yards to be complete soonest so as to further mitigate against ongoing potential windblown dust. MA again raised concern re the progress of the Acoustic fence 2.11 installation to the eastern boundary of the site. JB assured that the TSL/AMZ works would be complete by the next meeting. PMN – due to delays in manufacture the fence will not be complete until Mid Sept. Concern was raised in regard to Amazon Delivery vehicles and parkiung arrangements for to ensure local Highways were not congested with 2.12 same. SH explained that the development included for a full perimeter NOTE road upon which any trucks waiting to be offloading would be parked upon. Facilities for the truck drivers were also confirmed to exist within the Amazon site and as such drivers would be expected to use same MA referred to a Post and Rail fence that was proposed on the 2.13 Wykeland Land to be moved to the West of the pond to allow access for wildlife to. MA stated that ERYC were part of a local wildlife strategy group. He also stated that the pond had existed on OS Maps for some time, however that the pond was now dry. He asked it could be confirmed if the loss of retained water within was deemed related to the Earthworks operations on site. SH/JB agreed to look into and confirm. SH/JB MA confirmed that East Riding Environmental were now calling for a discussion with ERYC re same **NOTE** MC confirmed that EYRC Public protection (David Howlitson) had been 2.14 invited to the next meeting to answer residents' questions specifically NOTE relating to Air Quality monitoring/issues within the wider area

MC had previously requested if TSI could assist in arranging 'cutting

back' of overgrown vegetation along the Footway/Cycleway to the

Northern Boundary. JB agreed to arrange same

3.0 Safety, Health & the Environment TSL updated during the meeting that over 150,000 person hours had 3.1 been completed with no incidents to date. It was confirmed that AMZ continually monitor TSL's on site EHS and that the site was deemed to be well managed NOTE The project had been subjected to a further visit by the CCS Inspector. 3.2 It had been awarded a CCS score 43/45 giving an average to date of NOTE 42/45. Road Sweeper remains in attendance together with small Diesel 3.3 powered jet wash units at the site entrance. TSL again reiterated they were pushing to get the internal access roads/tarmac and external service yards completed ASAP to further mitigate against mud/debris TSL leaving site TSL confirmed that all the Cut/Fill Earthworks operation and piling was 3.4 complete. TSL also noted that they were pushing completion of NOTE external hard finishes to minimise the potential for dust to be generated during the works. Damping down was being undertaken continuously to control same.
