We believe it is important to keep our Neighbours informed about our activities to ensure transparency and minimize any inconvenience caused.

We have taken all necessary measures to ensure that the construction work is carried out efficiently and safely, adhering to all local regulations and guidelines.

During these periods, there may be some temporary disruptions in the vicinity, such as increased noise levels, dust, and occasional traffic congestion. However, we assure you that we will make every effort to minimize any inconveniences caused to you and other Neighbours.



To ensure safety, we have a professional construction team with experience in similar projects. They will take all necessary precautions to ensure the workers' safety and minimize any impact on the surrounding area. We have also coordinated with the relevant authorities to ensure that all necessary permits and approvals are in place.



PROGRESS UPDATE

The super-structure phase of the project is progressing well with close engagement with Key Stakeholders and the Local Council, in our Monthly Community Liaison Meetings.

All below ground service ducts and drainage nearing completion, concrete yard slabs continue to the south elevation and the acoustic fence line continues alongside the open space corridor.

Structural Steel Works nearing completion to the main build footprint with installation of the Metal decking following through. The Main frame steel to the office has commenced.

Roofing and cladding progressing well and on programme and glazing commenced to the west elevation.

ENVIRONMENT

Looking after the environment is key to TSL. To reduce any unnecessary emissions, reduce traffic flow to site an Onsite Concrete Batching Plant was put in place.

Benefits were as follows:

- Improved quality control
- Reductions in embodied carbon was 59% with 2% reduction from avoided vehicle movement with onsite batching.
- An emission reduction of 39% on concrete due to adaptions with mixed design and use of onsite batching.
