## Men in Sheds



North Ferriby has been invited to join in the formation of a **Men in Sheds group** covering the settlements of North Ferriby, Swanland, Hessle, Willerby, Anlaby, West Ella and Kirk Ella.



Sheds are community spaces for men to connect, chat and create. The activities are often similar to those of garden sheds but for groups of men to enjoy together. They help to reduce loneliness and isolation but most importantly they are fun. Although labelled sheds, they often are not sheds at all. They can be empty offices, Portakabins, warehouses or garages.

Many groups start out without a shed but meet regularly for the social connection, company and camaraderie until they find premises. Typical activities include woodworking, metalworking, repairing and restoring and some groups get involved in community activities ie restoring village features, helping maintain parks and green spaces and building things for schools, libraries and individuals. East Riding Council is putting some money forward to help to get a shed going in our area but once a shed is established it is expected to be self-sustaining, covering costs such as insurance and essential training.

The Parish Council is supportive of such a project and would like to hear from residents that might be interested in joining a Shed group, either one that might be based in the Anlaby area or one closer to home covering a smaller geographical footprint. ## Night-time Noise

For some months local residents have been hearing a low droning/rumbling noise, particularly at night. We are grateful to residents that have helped us to identify the source of the noise. With ward councillors, we have been actively lobbying ERYC to bring an end to the noise which was occurring on land in Gibson Lane south of the railway line. Heron Foods were storing loaded wagons of frozen food, kept refrigerated by diesel engine generators that were causing the disturbance. Public Protection at ERYC has been most helpful and placed sound recording equipment in homes in both North Ferriby and Melton, as well as carrying out their own night-time observations.

We are pleased to report that Public Protection has assessed the noise to be a statutory nuisance. The company has agreed to move all overnight refrigerated wagons back to Jackson Way from Saturday 17<sup>th</sup> August, using Gibson Lane only during the day for loaded vehicles but storing empty wagons there overnight. Any future over-night use of Gibson Lane for loaded vehicles will be subject to approval by Public Protection and then only with alternative means of refrigerating the vehicles. The situation will be monitored in the meantime. ## Transwaste Activities on Gibson Lane

**Planning refusal appealed.** The planning application for 24 hour working refusal by has been appealed. The appeal reference is APP/E2001/W/19/3231553.

The closing date for comments will have passed by the time you read this but any comments made by residents to the original application will be considered by the Planning Inspector. The appeal is to be decided by written representations only and so there will not be an opportunity for councillors or the public to make personal comment. The Parish Council will be making written representation and this will be posted on our website. It is expected that a decision will be made by the end of October.

**Duplicate application submitted to ERYC for 24 hour working.** The company has also submitted a duplicate application to the council for consideration.

**Odour issues.** You will be aware that Transwaste is treating increasing amounts of compostable waste, that has led to a sweet smelling, sickly compost smell drifting over the village from time to time. **Transwaste is required to control odours from its site**, therefore any incidents should be reported to the Environment Agency.



To report an incident regarding odour or noise, call the Environment Agency 24hr Incident Hotline on 0800 80 70 60. The operator will ask you for some simple information regarding the incident. It is important that Environment Agency have an accurate record of incidents to be able to take action, so please report the incident as quickly as possible and be accurate and honest with your report. Your details are confidential and will not be disclosed to anyone.

**Fire at the plant.** The cause of the fire on 4th August is being investigated by agencies and enforcement action will be taken if appropriate. We consider that this has impacted adversely on our village with mountains of waste being stored outside.

We are working with ward councillors to try to bring about urgent improvement and we are grateful that the local MP is supporting us in this
