## New Bus Service 150

Thank you to those residents that completed the bus survey. We are delighted to confirm that a new bus service, the **150**, will commence as a trial on Tuesday 6th July to run on **Tuesdays and Thursdays** until the end of March 2022, when the passenger numbers will be reviewed. The service commences on Ferriby High Road to do a loop of the village via Church Road, New Walk and Corby Park before heading to the Sandpiper in Melton.



It returns to the village along Melton Rd/High Street to go up Swanland Hill and West Leys Road. The service travels via Swanland Pond to Hessle Square and on to Sainsbury's. It returns via Hessle Square and back along Ferriby High Road. There would be four loops of the route each day commencing at **9.30am, 10.30am, 11.30am, 1.15pm**. The 11.30am loop allows time for the driver to have a lunch break. There will also be a **2.15pm** departure from North Ferriby but it will terminate at Swanland Pond. Please check the details before you commence your journey just in case of changes.

## Post Office@The Duke

We have been working hard with the Post Office after residents expressed their concerns about no facility in the village. An outreach service is now being provided at The Duke of Cumberland pub on Mondays, 9.30am – 12.30pm.

## Coronation Gardens

The Parish Council needs to undertake repair work to the wall around Coronation Gardens due to several significant cracks having recently appeared. Unfortunately, the cause of some of the damage is from the Yew tree and Holly tree in the southern corner that are growing too close to the wall, and these trees will have to be removed in order to carry out the repairs. The aim is for this work to be done during the school summer holidays to minimise the disruption.

## Plot E Melton Fields

The Parish Council has commissioned several images of the proposed distribution and fulfilment centre based on the submitted planning documents by Wykeland.

These have been produced by a nationally respected landscape consultancy and we believe are more realistic than those produced by the developer and showing on the ERYC planning website on 5<sup>th</sup> March.

They will be uploaded to the planning website by the end of this month but we wanted to share these views with residents before doing so.


The successful challenge by the parish council on the lack of an Environmental Impact Assessment means that the application is unlikely to go to Planning Committee before August, but is more likely on September 9<sup>th</sup>.

from same view point




View from the edge of Long Plantation  
showing 5m high acoustic fence



## Refresh of the East Riding Local Development Plan

Planning is a matter of high importance for our residents at present and what is contained in the Local Development Plan is the basis on which future decisions will be made. The plan is currently being refreshed and is now out for public consultation, so please make every effort to consider it and make your views known. Hard copies are available at the library but all documents are available online at [www.eastriding.gov.uk/localplanupdate](http://www.eastriding.gov.uk/localplanupdate).



The key changes affecting North Ferriby are:

**FER-A** - Godfrey Robinson Home, no longer included for additional housing.

**FER-D** – Grange Lane site, no longer included for additional housing.

**FER-B** – site next to the school on Ferriby High Road increased from 113 homes to 141 to compensate for the removal of FER-A and FER-D. There is no longer a requirement for FER-B to provide outdoor sports facilities and the Parish Council is objecting to the loss of the much needed pitch space

**Melton E.** There is positive news about land to the west of North Ferriby. There is now a requirement that new development must not adversely affect the amenity of neighbouring residential areas in terms of noise and pollution, and it should protect the character and ecological value of the plantation that runs along the eastern boundary of the site. However, the public open space to the west of the Long Plantation is still recorded as employment land and the PC will be asking that the plan be amended accordingly.

**Comments must be submitted by 6<sup>th</sup> August.** Our initial considerations will be on the PC website before submission.

The present shed was erected in the 1960's and is now in a very poor condition. The new building should be in place by the autumn.

It has been funded by a wind farm grant, a Co-op community grant and a grant from the developers Tilbury Douglas Construction who will help with its positioning.
