137. APOLOGIES FOR ABSENCE – Cllr Richardson & Ward Cllr Walker submitted apologies.

- **138. DECLARATIONS OF PECUNIARY OR NON-PECUNIARY INTEREST -** Declarations are recorded at the appropriate minute.
- 139. MINUTES OF THE PARISH COUNCIL MEETING HELD ON 22 FEBRUARY 2021 Resolved that the minutes be approved as a correct record and signed by the Chairman.
- **140. PUBLIC FORUM** There was no public speaking.
- 141. CHAIRMAN'S REPORT The Chairman briefly reported that amended plans had been submitted for the planning application on Plot E requiring further consultation, a meeting of the working party had been held with Save Ferriby 2020, and a request has been made for Tree Preservation Orders to be issued on the veteran oaks called T3 and T4 in P.A. 20/03555/STPLF. It was also noted that a decision was taken to include a local transport survey with the Spring Newsletter, which incurred costs of £157 + VAT.
- 142. EAST RIDING WARD COUNCILLOR'S REPORT Ward Cllr Abraham reported that she had attended the meeting with EYMS regarding the bus service, but that they will not alter the recently made changes. ERYC have the opportunity to fund a new trial service which could link North Ferriby, Swanland and Hessle, and the interest for this will be gauged by the response to the survey. An update regarding the legality of the Open Space was given and the requirement for ERYC Cabinet to approve its change of use was explained, as this would be needed in additional to any planning approval.
- 143. CLERK'S REPORT The Clerk reported that there had been no response from Hessle Grange GP following the letter that was sent. The safety issues raised with Network Rail regarding the footpath running along the edge of the Humber will be addressed, but a full footpath closure will be required. The Post Office is working to provide an outreach service based in the Pub for one afternoon per week. Finally there has been an significant number of noise complaints both from the Melton West site and also about lorries parking in the bus stops on Melton Road due to the loss of parking on Brickyard Lane.
