- 53. APOLOGIES FOR ABSENCE Cllr Blogg submitted apologies.
- **54. DECLARATIONS OF PECUNIARY OR NON-PECUNIARY INTEREST –** Declarations are noted at the appropriate minute.
- **55. MINUTES OF THE MEETING HELD ON 10 FEBRUARY 2021 Resolved –** that the minutes be accepted as an accurate record and were signed by the Chairman.
- 56. PUBLIC FORUM There was no public speaking
- **57. PARK WARDEN'S REPORT -** The Park Warden reported that there is damage to the fence between the play area and the skate park. It was also noted that glass bottles were smashed in the skate park but all broken glass was removed.

58. CLERK'S REPORT

- **58.1. Monthly report -** The Clerk reported that there the electric connection for the new CCTV cameras has been installed and cameras will be fitted shortly. A single rat was found in the pavilion but there is no evidence of a widespread problem. It was agreed that the water should be switched on again. A request has been received for a football camp to be held on the playing fields during the Easter holidays and it was agreed that this was acceptable. Finally the ERYC contractor working on the railway footpath is prepared to repair the footpath onto the playing field whilst he is in the area, if the stone is delivered to the site. It was agreed that £150 would be spent on materials and labour for this repair.
- **58.2.** The financial position of the Playing Field Committee was noted. No concerns were raised.

59. OTHER MATTERS

- **59.1.** Entrance to Playing Fields It was noted that the new chain and posts have been installed at the entrance to the Playing Field. It was agreed that 2 standard No Parking signs would be purchased by the clerk and installed on the gate at a maximum cost of £75. It was also agreed that the Ambulance Service would be given the code for the locks.
- **59.2.** Request to Use form The form was updated for 2021/22 and it was agreed that it would be sent to all users, including the youth football managers, to help prevent conflicts with the youth football and cricket seasons running at the same time due to COVID.
- **59.3. Zip Wire** A quotation from the manufacturer has been received. It was agreed that a recommendation would be made to the Parish Council for £3716 + VAT should be spent on the repairs, however it would also be reviewed if this could be funded using the remainder of the Commuted Sum grant.
- **59.4. ERMOS** It was noted that the ERMOS renewal application had been submitted to ERYC.
- **59.5.** Litter Bins This item will be discussed at the next meeting
