- 86. MINUTES OF THE PARISH COUNCIL MEETING HELD ON 23 OCTOBER 2023 Resolved that the minutes be approved as a correct record and signed by the Chairman.
- 87. **PUBLIC FORUM** There was no public speaking
- **88. WARD COUNCILLOR'S REPORT** Ward Cllr Corless reported that MS3 have submitted plans for telegraph poles to be installed in the conservation areas of the village but ERYC have objected to these plans. Currently it is not clear what will happen next. She also updated the Council regarding a request for a reduction to the speed limit on Ferriby High Road, a burst water pipe and efforts to get the veteran oak tree on Melton Fields, known as T3, moved rather than felled.
- 89. CLERK'S REPORT The Clerk updated the Council with a short report about recent correspondence. It was noted that a S19 report will be carried out into flooding that took place across the East Riding during September and October and this will include the 2 events in Ferriby. It was reported that a meeting had taken place between the Clerk and Cllrs J.Abraham and Allmendinger to discuss what was required in order to operate a Facebook page. Finally the latest preparations for the Christmas activities were reviewed.
