## NORTH FERRIBY PARISH COUNCIL MINUTES 24 April 2023

- 153. APOLOGIES FOR ABSENCE Cllrs Black & Blogg submitted apologies.
- **154. DECLARATIONS OF PECUNIARY OR NON-PECUNIARY INTEREST –** Declarations are recorded at the appropriate minute.
- 155. MINUTES OF THE PARISH COUNCIL MEETING HELD ON 27 MARCH 2023 Resolved that the minutes be approved as a correct record and signed by the Chairman.
- **156. PUBLIC FORUM -** A member of the public attended to observe proceedings.
- 157. CHAIRMAN'S REPORT The Chairman noted that this was the last meeting for the term of the Council and expressed thanks to Cllr John Mabbett for the time he had served on the Parish Council. Thanks were also given to Ward Cllr Abraham who is standing down at this election after 20 years' service.
- 158. WARD COUNCILLOR'S REPORT Ward Councillor Abraham reported that the white lines at the Nunburnholme junction had been refreshed as requested. Following a meeting with an officer from ERYC it had been agreed that two new trees would be planted on New Walk to replace the recent ones that had been felled. However the presence of telephone lines restricted further trees from being planted. Correspondence had been received from the railway station asking for views about installing tactile paving and this idea had been supported. Finally it was noted that ERYC have completed the installation of the CCTV at the Melton underpass, but further information had been requested from ERYC to clarify the ongoing maintenance of these cameras.
- 159. CLERK'S REPORT The Clerk reported that she had sent residents of Redcliffe Drive and Humber Road a letter explaining how to report any issues with antisocial behaviour to the police. She has also had a meeting at the Methodist Church to investigate the possibility of installing a defibrillator on the front of the building and hopes to have an answer by the end of May. It was noted that the Allotment Committee AGM was taking place on 25th April. Finally it was agreed that a letter of congratulations should be sent to North Ferriby Football Club following their back to back promotions.

- **162.2.** Local Plan Update Submission It was noted that following the Parish Council's submission in December the following changes are to be included in the Local Plan Update.
  - Reinstatement of the area of open space for the housing allocation FER-B which will provide much needed additional football pitches alongside the Playing Fields
  - Recognition of the Open Space to the east of Long Plantation
  - Strengthening of the policy wording for Air Quality Management

- **162.4. Transwaste** It was noted that whilst 24 hr operation at the Transwaste site had been approved by ERYC Planning Committee, it was hoped that the new conditions applied to the whole site would reduce the impact of noise and odour and would be enforced by ERYC.
