- 67. APOLOGIES FOR ABSENCE Cllr Blogg, Shaikh and D.Morgan (Ferriby Shed) submitted apologies
- **68. DECLARATIONS OF PECUNIARY OR NON-PECUNIARY INTEREST** Cllr Wood declared an interest as a member of the Bowls Club and D.Wyndham declared an interest as a member of the Cricket Club.
- **69. MINUTES OF THE MEETING HELD ON 13 MARCH 2024 Resolved –** that the minutes be accepted as an accurate record and were signed by the Chairman.
- 70. PUBLIC FORUM There was no public speaking.
- 71. **PARK WARDEN'S REPORT –** The Park Warden reported that it had been a quiet month. He has removed the moss from under the play equipment, cleared the mud under the zip wire track and trimmed back the trees near the zip wire.

72. CLERK'S REPORT

- **72.1.** Monthly Report The Clerk reported that the new tennis net, the water heater in the pavilion and the new fence panels around the skate park had been fitted. It was also noted that the Park Warden would be reducing his hours to 4 days a week.
- **72.2.** The financial position of the Playing Field Committee was noted. It was agreed that a change to the way the grant from the Parish Council is paid would be requested. Rather than 50% being paid in May, a larger proportion is required to cover the higher costs during the summer months.

73. OTHER MATTERS

- **73.1.** Grounds Maintenance It was noted that the outgoing contractor did not carry out the final 2 cuts of the contract, which were due in March. Instead the costs were refunded and the new contactor was asked to carry out an additional cut.
- 73.2. New sign for Ferriby Shed This item was not discussed and will instead be put on the next agenda.
- **73.3. Tennis Courts** Following correspondence from a resident regarding the surface of the tennis courts, quotations were reviewed for different methods of cleaning. It was agreed that the quotations from the cleaning companies were too costly and potentially to aggressive for the surface. It was agreed that other options would be considered and discussed at the next meeting.
- **73.4.** Showers It was agreed that the Cricket Club would nominate a member who would be responsible for the legionella checks being carried out before the start of each home match. The Clerk will then set up the system to be followed.
- **73.5.** Cricket Club It was reported that all the fixtures were now listed on the Parish Council website and that the changing rooms had been repainted.
