11. **APOLOGIES FOR ABSENCE** – Cllrs M.Abraham, Knight, Shaikh & D.Wyndham (Cricket Club) submitted apologies.
12. **DECLARATIONS OF PECUNIARY OR NON-PECUNIARY INTEREST** – Cllrs Blogg & Wood declared an interest as a members of the Bowls Club and D.Morgan declared an interest as a member of the Ferriby Shed.
13. **MINUTES OF THE MEETING HELD ON 12 JUNE 2024 – Resolved** – that the minutes be accepted as an accurate record and were signed by the Vice Chairman.
14. **PUBLIC FORUM** – There was no public speaking
15. **PARK WARDEN’S REPORT** – The Park Warden reported that there had been no issues again in the park and it was noted that the front of the tennis and bowls clubs had been strimmed.
16. **CLERK’S REPORT**
 - 16.1. **Monthly Report** – The Clerk reported that the tennis courts had been sprayed and one of the CCTV cameras had been fixed. It was also agreed that the risk assessment for the Playing Field will be reviewed in Aug by Cllrs Wood and Holborn.
 - 16.2. The financial position of the Playing Field Committee was discussed. No concerns were raised.
17. **OTHER MATTERS**
 - 17.1. **Play Park Gate** – The quotations for a replacement gate were reviewed and it was agreed that the quote from Tony Cook Ltd for £1950 + VAT would be recommended to the Parish Council for approval.
 - 17.2. **Ferriby Shed** – The Clerk provided information from the planning department, and it was agreed that a new application would be submitted for a prefabricated storage garage to be placed to the north of the pavilion.
 - 17.3. **Grange Lane Hedge** – New regulations came into force on the 23rd May 2024 regarding hedgerow management which apply to the Grange Lane hedge and restrict when it can be cut. It was agreed that, in order to comply with the new regulations, only the Grange Lane side of the hedge can be trimmed back to the kerb line between 1 March and 31 August in order to maintain pedestrian safety.
 - 17.4. **Cricket Club** – There was no update
 - 17.5. **Bowls Club** – It was agreed that the concerns over the sustainability of the club would be raised with the Trustees at their next meeting and that the Open Spaces officer at ERYC would be contacted for potential future ideas for the area.
