10. **APOLOGIES FOR ABSENCE** – Cllrs Black and Hookem submitted apologies
11. **DECLARATIONS OF PECUNIARY OR NON-PECUNIARY INTEREST** – There were none

14. **PUBLIC FORUM** – There was no public speaking
15. **WARD COUNCILLOR’S REPORT** – Cllr Corless reported that there was additional information submitted for the Transwaste application, that there will be a long road closure on Ferriby High Road and that she is trying to persuade Amazon to improve their commitment to use the south western exit from the yard for HGVs leaving the site.
16. **CLERK’S REPORT** – The Clerk gave an update on planned works on the highways that was provided by Cllr Hopton. It was also reported that complaints had been received about the contractors working on replacing the water pipes, which had been forwarded and were being dealt with quickly. Other issues raised by residents included dust from the soil movements on Plot E, electric bikes in Long Plantation, and the burnt out litter bin on the Riverside Walkway.

 - 17.3. **Annual Governance Statement 2024/25** – In accordance with the Accounts and Audit Regulations 2015, the Councillors agreed positively to the assertions that the Council has a sound system of internal control. It was **Resolved** that the Annual Governance Statement be approved and was signed by the Vice Chairman and the Clerk.
