- **12. DECLARATIONS OF PECUNIARY OR NON-PECUNIARY INTEREST –** D.Wyndham declared an interest as a member of the Cricket Club.
- 13. MINUTES OF THE MEETING HELD ON 11 JUNE 2025 Resolved that the minutes be accepted as an accurate record and were signed by the Chairman.
- 14. **PUBLIC FORUM** A member of the public attended to talk about trees overhanging his property.

- **18.4. Risk Assessment** It was agreed that Cllr M.Abraham, the Clerk and either Cllr Blogg or Wood would review the risk assessment in August.
- **18.5.** Bowls Club A brief verbal report was given.
