In the absence of both the Chairman and Vice Chairman it was agreed that Cllr Holborn would act as Chairman for the meeting.

19. **APOLOGIES FOR ABSENCE** – Cllrs M.Abraham, Shaikh and Wood
20. **DECLARATIONS OF PECUNIARY OR NON-PECUNIARY INTEREST** – Cllr Blogg declared an interest as a member of the Bowls Club, D. Morgan declared an interest as a member of Ferriby Shed and D.Wyndham declared an interest as a member of the Cricket Club.
21. **MINUTES OF THE MEETING HELD ON 9 JULY 2025 – Resolved** – that the minutes be accepted as an accurate record and were signed by the Chairman.
22. **PUBLIC FORUM** – There was no public speaking
23. **PARK WARDEN'S REPORT** – The Park Warden reported that it had been a quiet summer but with more litter than usual. It was also noted that the quarterly inspection had been completed. The zip wire requires a service and further repairs will be made to the wet pour in the coming weeks.
24. **CLERK'S REPORT**
 - 24.1. **Monthly Report** – The Clerk reported that on the monthly CCTV check there is an issue with the live broadcasting of 2 cameras, but reported that the images are being recorded so full coverage is in place. A resident has questioned whether some seating in the shade can be installed. The suggestion was briefly discussed and it was noted that the area behind the wicket should be avoided. This idea will be incorporated into the budget discussions.
 - 24.2. The financial position of the Playing Field Committee was discussed. No concerns were raised.
25. **OTHER MATTERS**
 - 25.1. **Playing Field Risk Assessment** – The risk assessment document was circulated before the meeting. No major issues of concern were raised and the actions required were agreed, which included expenditure on a replacement water heater for the pavilion toilet.
 - 25.2. **Bowls Club** – It was noted that following the suspension of the club over the summer, it would be closing due to lack of membership. It was agreed that the Clerk would meet with Cllrs Blogg and Wood before the next meeting to discuss the implications of this decision.
 - 25.3. **Allett Mower** – In accordance with paragraph 4 of the Joint Ownership and Use Agreement, it was noted that the Allett Mower will now transfer to the ownership of the Cricket Club. Should the Bowls Club be relaunched, then the mower will transfer back to joint ownership.
 - 25.4. **Electric Supply to Score Box** – The Cricket Club wish to investigate installing an electric supply to the score box. It was agreed that the best approach would be for the club to contact Norman Jarvis & Son Electricians directly to scope out the project.
 - 25.5. **Grounds Maintenance of Bowls Area** – The two quotations for the grass cutting of the green and surrounding area were discussed. It was agreed that the job would be offered to SJK Garden Services in the short term, but if it is too time consuming then Ferriby Fencing would be asked to do the work. The funds allocated in the budget for the Bowls Club are sufficient to cover the new cutting and strimming costs.
