- 16. APOLOGIES FOR ABSENCE Cllr Holborn submitted apologies
- 17. DECLARATIONS OF PECUNIARY OR NON-PECUNIARY INTEREST There were none.
- **18. MINUTES OF THE MEETING HELD ON 21 JULY 2025 Resolved –** that the minutes be approved as a correct record and signed by the Vice Chairman.
- 19. PUBLIC FORUM There was no public speaking
- 20. CLERK'S REPORT
  - **20.1. Monthly Report** The Clerk informed the committee that the Countryside Access Officer for the Yorkshire Wolds Way had left ERYC. An update of correspondence about dog muck was also given. It was noted that on Saturday 20th September one of the trees on New Walk failed, luckily missing any parked cars, but it was agreed that ERYC should be contacted to ask that a full assessment be carried out on all the Horse Chestnut trees on the street.
  - **20.2.** The current financial position was reviewed. No concerns were raised.

## 21. OTHER MATTERS

- **21.1. Station Adoption** Following the meeting at the station it has not been possible to find anyone to take on the leader's role for the group, a deputy leader is in place. Therefore it was agreed that the Clerk would take on this position to enable the group to be established as there were a significant number of people interested in volunteering.
- **21.2. War Memorial** The Clerk gave an update following a conversation with a structural engineer, who having reviewed the photos sent of the base plinth, was not concerned about the stability. He did suggest however contacting a stone mason to see if it was possible to treat the cracks that had formed. It was agreed that this and an annual review of the condition of the memorial would be carried out.
- **21.3. Humber Road Car Park** Following reports of van maintenance being carried out in car park, it was agreed that the company would be contacted and asked to stop using the area.
- **21.4.** New Notice Board The different styles of notice board were discussed, and it was agreed that one slightly larger than the existing one would be best but fixed to the existing framework. The Clerk will contact suppliers and get quotes that can be reviewed at the next meeting.
- **21.5. 40**th **Anniversary of the Riverside Walkway** It was agreed that an advert would be placed on the Village Hall screen asking for residents to come forward with information or memories about the creation of the Walkway, and that there should be a table about the event at 'Know Your North Ferriby'. It was also agreed that the previous clerk will be contacted.
- **21.6. Village Walk** It was agreed that this would be scheduled at a convenient date between the scheduled meetings.
- **21.7. Grant Application** Unfortunately the grant for new trees had already closed to new applications
