- 22. APOLOGIES FOR ABSENCE Cllrs J. Abraham and Holborn submitted apologies
- 23. DECLARATIONS OF PECUNIARY OR NON-PECUNIARY INTEREST There were none.
- **24. MINUTES OF THE MEETING HELD ON 22 SEPTEMBER 2025 Resolved –** that the minutes be approved as a correct record and signed by the Chairman.
- 25. PUBLIC FORUM There was no public speaking

26. CLERK'S REPORT

- 26.1. Monthly Report The Clerk informed the committee that the Ferriby Shed had repainted the interior of the Co-op bus stop. It was also noted that a resident had offered to revamp the War Memorial bus stop and the Committee agreed to accept this offer, subject to it covering the cost of materials. Some damage has occurred to the fencing near the War Memorial bus stop, and it was agreed to approach Beal Homes to enquire whether they would consider replacing the fence. Cogans Funeral Directors have offered to make a donation to the Parish, and it was suggested that this contribution could be allocated towards either the purchase new verge trees or a new noticeboard on the Riverside Walkway. Finally the information gained from the ERNLLCA Conference was shared and the work of TCV was noted.
- **26.2.** The current financial position was reviewed. No concerns were raised.

27. OTHER MATTERS

- **27.1. Letter** It was agreed that the Environment Committee would write a letter of thanks to a young child who has been litter picking in the village.
- **27.2. Tree Management Policy** The Committee reviewed the draft Tree Management Policy and made a few minor changes. It was agreed that the policy should be reviewed by the Playing Field Committee and then recommended to the Parish Council for adoption.
- **27.3. Riverside Walkway** It was agreed that the quotation received from Ferriby Fencing of £540 + VAT to remove a damaged tree from the far end of the Riverside Walkway would be accepted.
- **27.4. Correspondence from ERYC** The response regarding concerns about the health of the trees on New Walk was noted.
- **27.5. Bus Stop** It was agreed that the Primary School would be approached to supply new artwork for the Co-op bus stop.
- **27.6. Risk Assessment** The outcome of the Village Walk on the Riverside Walkway was noted and the updated Risk Assessment was approved.
- 27.7. Humber Road Car Park The clerk shared the confirmation from the company who was carrying out van maintenance on the site, that it would cease to do so and it was agreed that a 'No Overnight Parking' sign would be installed.
- **27.8. New Notice Board** The Committee considered the quotes received and agreed to place an order for a new glazed notice board for Coronation Gardens with Greenbarnes at a cost of £2304.25 + VAT
- **27.9. 40**th **Anniversary of the Riverside Walkway** The clerk updated the Committee with the information provided by the previous clerk, and it was suggested that it might be helpful to set up a working party with those formerly involved with the site to pull together the information required.
- 27.10. Budget 2026/7 An initial discussion about the items to be included on next year's budget was had.
