- 98. DECLARATIONS OF PECUNIARY OR NON PECUNIARY INTEREST There were no declarations
- 99. MINUTES OF THE PARISH COUNCIL MEETING HELD ON 27 NOVEMBER 2017 Resolved that the minutes be approved as a correct record and signed by the Chairman.

- 103.4 Precept The precept was approved at the meeting. It was **Resolved** that a precept demand of £74,400 for 2018/19 would be submitted to East Riding of Yorkshire Council. This level of precept is equivalent to £42.98 for a Band D house and remains unchanged from 2017/18 levels

- **108.2 Bank Account for the Playing Field** Following the advice from the Interim Audit and ERNLLCA, it was proposed by Councillor Payne that the balance of the playing field account be transferred from the Parish Council bank accounts and into the account registered against the Charity. This was seconded by Councillor Dennett and all voted in favour. This will be carried out following the advice of the auditor.

Further steps to improve the separation of the body of the Parish Council from the body of the Trustees of the Playing Field need to be taken, The clerk will work on the proposed changes and present to the Trustees at a future meeting
