	to the stem, remove the cluttered look. T3 Norway Maple: This tree as really only grown out to the south east, reduce this canopy extension by 1.5-2m. T4 Norway Maple: Large limb, leaving main stem on southeast aspect at 4m. Leans out and grows towards the house, source of roosting birds and the mess associated with it. Limb on westerly aspect elongates out 8-9m over adjacent boundary. Neighbours have mentioned this to tree owner, remove this stem entirely. Remove any epicormic on any of the trees whilst in the climbers vicinity
