**59. EAST RIDING WARD COUNCILLOR'S REPORT** – Ward Councillor Abraham reported that there had been a meeting with residents in Brough regarding traffic tailing back onto the A63 at the Brough exit during peak times, which is causing a hazard. This is also the case at the Humberfield exit and so officers have agreed to carry out an assessment of all the exits on the A63.

**60. CLERK'S REPORT** – The Clerk gave the Council an update of the complaints and issues that had been raised, which included concerns over the trees in Plantation Wood, blocked gullies and Ings Field. The cost of hosting the Remembrance Parade will not be met by the British Legion in future and this will be added to the agenda for next month.

**63. OTHER MATTERS**

**63.1** It was agreed that the Council would write to the Planning Inspectorate regarding the Appeal 19/00037/REFUSE for 24 hour operation at Transwaste, restating its objection to the application and detailing all of the issues of nuisance from the site's operation since April.

**63.2** It was noted that the Public Protection Team at East Riding has agreed that the noise from Heron Food lorries parking off Gibson Lane with refrigeration units running overnight constitutes a statutory nuisance and an abatement notice will be served if the activities are not stopped voluntarily by the company.

It was also noted that the terrible odour from the Transwaste site and the fire that started on 4<sup>th</sup> August is having a significant impact on the residents of North Ferriby. A meeting with both Ward Councillors, the Chairman of North Ferriby Parish Council and the Environment Agency officers responsible for overseeing the operation of the Transwaste site took place at the end of July to raise awareness of the impact that the operation of the site was having on the local vicinity. The clerk reported that she has received concerns from several residents over the plans that for Melton Fields and the proximity of the proposed warehousing to Plantation Woods. It was agreed that a letter should be sent to the Director of Planning to formally raise the concerns over the future development of this area.
