- **100. APOLOGIES FOR ABSENCE –** Councillors Black & Richardson submitted apologies
- **101. DECLARATIONS OF PECUNIARY OR NON-PECUNIARY INTEREST –** There were no declarations
- 102. MINUTES OF THE PARISH COUNCIL MEETING HELD ON 28 OCTOBER 2019 Resolved – that the minutes be approved as a correct record and signed by the Chairman. Proposed by Councillor J.Abraham, seconded by Councillor Blogg
- **103. PUBLIC FORUM –** One member of the public was present to observe the proceedings.
- **104. CHAIRMAN'S REPORT** The Chairman reported that Councillor Clark had resigned. Having attended a training session on the co-option process at the recent ERNLLCA conference, a brief outline of the learnings was shared with the Council. It was agreed that the vacancy needs to be filled by someone who can join the Playing Field Committee.

The Chairman also raised the idea of 'Happy to Chat' benches and it was agreed that the Environment Committee would consider this at their next meeting in the New Year.

105. EAST RIDING WARD COUNCILLOR'S REPORT

- **105.1** It was noted that both Ward Councillors had met with Wykeland on 13th November, to discuss the plans for Melton Fields. They took the opportunity to raise concerns over the potential for noise and air pollution from the site. The outline plan for a bund and wetland area are being included in the future development plans for the site, and these were discussed along with the expected timelines for the submission of planning applications which were shared with the Council.
- **105.2** It was reported that the public consultation stage of the Local Plan work has been delayed until September 2020 and the draft update for the Joint Waste Plan will be available during Autumn 2020 as well. The ERYC is also undertaking a Strategic Flood Risk Assessment review which will form part of the evidence required for the Local Plan review.

106. CLERK'S REPORT

- **106.1** The Clerk gave an update of all the arrangements that have been made for Christmas and reviewed the key action associated with the risk assessments. It was agreed that mince pies, mulled wine, nice biscuits and cordial would be purchased and served after Carols by the Lychgate.
- **106.2** The Clerk provided the Council with her monthly report which included a review of recent complaints that had been received. The 2020 meeting schedule was issued and the area wardens on the Emergency Plan were updated.

- **109.1 Repairs to Railway Line** It was noted that the Environment Committee had a meeting with Story Contracting about the project to repair the railway embankment. The current plan is for the work to start in April 2020 and for the Riverside Walkway to be used as the site access from the start of the meadow area onwards. Story Contracting also wish to use part of the end of the Riverside Walkway for parking and as a storage compound. The exact position of this area will be reviewed so that the impact on the established trees is minimised.
- **109.2** Local Plan It was agreed that Cllrs Mabbett, Hookem and J.Abraham would request a meeting with ERYC to continue discussion regarding the specification of Melt-E in the Local Plan
- **109.3** Youth Facilities Cllr Holborn raised the issue of trying to create more youth facilities in the village. It was agreed that this would be discussed with the Head of South Hunsley School when he comes to the PC meeting in January
- **109.4 Community Builders** Cllrs J.Abraham and Dennett attended a meeting with the aim of trying to improve the links between organisations in Swanland and North Ferriby, such as the village halls and churches, to make sure that residents in both villages are aware of all the activities that are taking place in each community and to discover if there are any gaps for new opportunities. A further meeting has been arranged in January

- **109.6** Election of a Chairman of the Playing Field Committee Following the resignation of Cllr Clark, Cllr M.Abraham was elected as Chairman of the Playing Field Committee. He will also sit on the Personnel Committee but it was agreed that this would not be at the same time as Cllr J.Abraham.
