- 119. MINUTES OF THE PARISH COUNCIL MEETING HELD ON 25 NOVEMBER 2019 Resolved that the minutes be approved as a correct record and signed by the Chairman. Proposed by Councillor J.Abraham, seconded by Councillor Blogg
- 120. PUBLIC FORUM There was no public speaking
- **121. CHAIRMAN'S REPORT** It was noted that one application to join the Parish Council had been received. Following a discussion, it was agreed that the applicant should be co-opted at the next meeting.
- **122. EAST RIDING WARD COUNCILLOR'S REPORT** It was noted that Ward Councillors Abraham and Walker would be attending a meeting with officers from ERYC regarding Transwaste. Cllr Abraham will report on the outcome at the next meeting. It was also noted that at a Brough South Development meeting a planning application has been received for an Aldi store to be located on the site.
- 123. CLERK'S REPORT The Clerk provided the Council with her monthly report which included a review of recent complaints that had been received. There have been significant complaints regarding the fire, noise and odour from Transwaste with evidence that the site has been operating outside of their approved opening hours, all of which has been reported to the relevant authorities. A discussion was also had regarding the concerns expressed by residents about the level of water in the Reed Pond and Ings Field. A set of actions was agreed to follow up this issue.
